The Next Ag Policy Framework

Your input

At a June 16 BC Agriculture Council meeting, the balance between “Risk Management” programs and “Strategic Investment” programs was discussed. Risk management programs provide insurance against different types of risks:

- **AgriStability** provides coverage for steep drops in net income (i.e. if the ‘program margin’ drops by more than 30% drop, participants receive a percentage coverage of 70% on the drop in margin that is over 30%).
- **AgriInsure**, or Production Insurance, can help with up to 80% of crop loss (with the many deductibles, 5 year averages and so on, the actual amount received for a loss is often less).
- **AgriInvest**, which provides a matching contribution to an account to be used for ‘rainy days’.
- **AgriRecovery**, which can help with recovery costs not covered by other programs.

The provincial and federal governments decided, in the last Agriculture Policy Framework, to reduce Risk Management programs and increase Strategic Investment programs, including

- **AgriInnovation** (funds the introduction of innovative equipment and products)
- **AgriCompetitiveness** (funds business education, industry studies through the national Value Chain Roundtables, and the Minor Use Program for more rapid access to new, safe, modern crop protection products)
- **AgriMarketing** (funds export market access and quality assurance programs)

At recent meetings, BCFGGA has started to explore the introduction of new eligible projects for EFP. EFP projects are called Beneficial Management Practices or BMPs. BCFGGA has a goal to expand EFP participation so that growers can receive a fair share of BMP funding while making progress in transitioning their farm to new, innovative practices that help the environment.

If we are successful in establishing new BMPs that are meaningful to tree fruit growers, growers will be encouraged to complete EFPs after the Fall harvest.

Unmanned Aerial Systems



Summerland Varieties Corporation is moving forward with technology that delivers enhanced agricultural intelligence, potentially making the allocation of valuable resources easier for local growers.

Remote sensing technology is widely used in larger-scale satellite imagery, but SVC will be testing this technology closer to home, and to a scale that's most helpful and tailored to the needs of growers in the Okanagan Valley.

Unmanned aerial systems - most commonly known as drones, can assist growers with optimizing management techniques by variety.

Drones can provide detailed orchard information that may assess tree health, vigour, weather damage or measure whether trees are under water stress, making it simpler to determine where to allocate resources and irrigation programs, leading to better crop uniformity.

Drones will only be used with the full knowledge and consent of property owners, and will fly in preprogrammed and agreed-upon flight patterns.

Transport Canada requires that operators of all unmanned aerial systems apply for a Special Flight Operations Certificate (SFOC) for the region in which they will fly. SVC is proud to partner with Hummingbird Aerial Surveys, who are approved by Transport Canada, and the Ambrosia Council who are funding partners.
