WORKING TO MAKE A DIFFERENCE

The requirements for handling pesticides in the workplace are complicated due to several federal, provincial and even municipal government statutes, regulations and by-laws. The major regulations are the Pesticide Control Act which requires pesticides to be registered with the Pest Management Agency, the Occupational Health and Safety Regulations, administered by WorkSafeBC that provides provincial legislative protection to workers, and the Integrated Pest Management Act and Regulations which is administered provincially by the Ministry of Environment and covers certification, licensing and permit restrictions.

As an update to growers, the Pest Management Regulatory Agency (PMRA) has recently re-evaluated several older pesticides and has made changes to their labels. Diazinon must now have a Pesticide Applicator Certificate to mix, load and apply. This change is also in effect for dimethoate (Cygon and Lagon) and endosulfan (Thiodan). The rodenticides will also see similar label changes. WorkSafeBC regulations already required a Pesticide Applicator Certificate for use of these pesticides as well as any other insecticides rated as moderately or highly toxic.

Other common pesticides requiring a PAC by WorkSafeBC include Sevin, Imidan and Gramoxone. Important sources of information regarding specific pesticides include the label, WorkSafeBC's Standard Practices for Pesticide Applicators, Material Safety Data Sheet and Production Guide. Labels are now being regularly reviewed by PMRA, it is important to read the label prior to use to ensure the right product is being used the right way on the right fruit.

According to the OHS&R those who mix, load or apply chemicals must have a Pesticide Applicators Certificate. The certificate is obtained by writing a test administered by the Ministry of Environment. You can prepare for the test by taking a course from an approved trainer or by using the Ministry of Environment study material. To write the test for a Pesticide Applicator Certificate, contact the Ministry of Environment at 1-866-205-2102. The agriculture applicator exam is currently open book and is available in the following languages English, Cantonese, Punjabi and Vietnamese.

Another important topic is the requirements for first aid certificates and kits. This varies with the number of workers working on shift, the level of risk of injury and travel time to a hospital. All workers on site must be counted to determine first aid requirements which would also include outside contractors. As an example, the requirement for 6 to 25 workers in a moderate risk industry such as orchards that is less than 20 minutes to a hospital is below.

New Requirements for Roll Over Protection System

Due to the number of deaths and injuries from tractor roll-overs in recent years, WCB is implementing new requirements for Roll Over Protection System (ROPS).

All tractors will be required to be fitted with ROPS, unless:

- The tractor is older than 1985, or it is a low profile tractor used in low overhead clearance in an orchard, or implements are attached which are not compatible with ROPS, AND
- A risk assessment is completed by a qualified person and a notice is posted on the tractor that no ROPS is in place and the tractor is only to be used in areas authorized by the employer.

Implementation date is not clear at this time.

BCFGA Meets With Premier and Key Minister During *Agriculture Day in Victoria*

On November 2, representatives from the member associations of the BC Agriculture Council (BCAC) gathered in Victoria, BC for a special lobby day at the Legislature. BCFGGA President Joe Sardinha attended on behalf of our association.

The focus of the day was to not only highlight the significant employment and other economic contributions of BC agriculture, but to also point out that new investment is critical to drive growth, competitiveness and profitability in the sector. At present this investment is the lowest among Canadian provinces and BC has experienced negative net farming income for the past four years.

Representatives also met with MLA's and Ministers and staff of Agriculture, Labour, Health, Energy and Natural Resource Operations.

High on the BCAC list of priorities for elected officials to consider were:

- 1) establishing a PST and GST rebate system for farmers that essentially provides the same benefit as the HST, which will be phased out,
- 2) elimination of the carbon tax, as it creates an additional burden for farmers, and
- 3) to consider the impact of rapidly rising employment wage rates (minimum wage) on agriculture, and in particular piece rates if they are to increase in tandem.

Another key theme of the day was that the Agriculture Ministry is seriously underfunded and is therefore ill-equipped to tackle the many issues facing BC agriculture. Throughout this lobbying day, BCAC participants conveyed the following messages; ***strong support for continuation of the BC School Fruit and Vegetable Nutrition Program, increased funding for secondary school culinary programs that focus on healthy food, funding for a local food campaign such as "Buy BC" , increased collaboration among Ministries that will generate more resources since agriculture is multi-faceted, more investment in on-farm renewable energy projects and less red tape for ranchers operating on crown land.*** Another lobbying opportunity may be planned for the spring of 2012.

BC Tree Fruit, Potato and Vegetable Sectors Meet with Minister of Agriculture on Columbia River Treaty

This past October, representatives of the BC tree fruit, potato and vegetable sectors met with BC Agriculture Minister, the Hon. Don McRae, to discuss the negative impact that the Columbia River Treaty (CRT) has on the BC vegetable, potato and tree fruit sectors.

During this meeting, requests were put before the minister's attention for consideration:

- The appointment of a senior BC Ministry of Agriculture staff member to the established BC Ministry of Energy and Mines Task Force to represent the industry in the CRT renewal process;
- The establishment of a consultation process involving representatives from the affected sectors and BC Ministry of Agriculture staff members; and
- The availability of funds to permit research to be undertaken to better respond to the challenges facing the tree fruit, potato and vegetable sectors.

Representatives of the BCFGA, BC Potato & Vegetable Growers Association, and BC Vegetable Marketing Commission appreciated meeting the Minister to discuss this issue facing our industries, and hope to continue working with him and the provincial government on finding solutions.
