Terms and Conditions:

1. The Applicant acknowledges that the British Columbia Fruit Growers Association ("BCFGA") will rely upon the information provided in this application and its attachments (the "Application") in assessing the Applicant's eligibility for funding under the 2010 Tree Fruit Replant Program, Grafting/Budding Grant Application. The Applicant acknowledges that no funding will be issued under the Program until final inspection and confirmation that the grafting/budding has been carried out in accordance with the requirements of the Program.
  2. The Applicant certifies, acknowledges and confirms that the following statements are true statements of fact as of the date of making this Application (for further information contact BCFGAs for assistance):
    - (a) all information provided in the Application is true, correct and complete;
    - (b) the Applicant has read and understands the Guidelines for the Tree Fruit Replant Program, and the Guidelines for the Grafting/Budding Grant Application;
  3. As a requirement for funding under the Program, the Applicant agrees to:
    - (a) permit, at any reasonable time, representatives of the BCFGAs, and the Province of British Columbia to conduct inspections of the Lands and audits of all of the Applicant's records or accounts relating to funds received under the Programs. The Applicant agrees that the BCFGAs is not liable or responsible for any loss or damage which may be caused by any inspector or auditor in connection with inspections or audits related to the Program;
    - (b) be bound by the appeal process set out in the Guidelines;
    - (c) provide BCFGAs with proof of payment of royalties or plant material used in the project, at anytime on request. The Applicant authorizes BCFGAs to share such information with the Okanagan Plant Improvement Corporation (PICO) or the applicable nursery for the purposes of verifying payment of such royalties;
    - (d) repay any and all funds which may be granted under the Replant Program if for any reason the trees grafted or budded over under this Project are removed within 5 years of the date of grafting/budding (including due to a sale of the Land to a third party who removes the trees during the time period), unless BCFGAs determines, in its sole discretion, that the grant is not repayable due to unforeseen circumstances; and
    - (e) repay any and all funds which may be granted under the Programs to which the Applicant is not entitled.
  4. The Applicant will pay interest on repayments of funding under the Programs at the rate of 1.5% per month (18% per annum) calculated from the date BCFGAs issues a notice requiring repayment of funding.
  5. The Applicant consents to the collection, use and disclosure of the personal information contained in this Application for the purposes of managing the Programs, complying with the requirements of the Provincial and Federal Governments in connection with reporting and administration of the Programs, verifying eligibility for funding, conducting inspections and conducting audits. Any information, with the exception of personal financial information unless in aggregated form, furnished in this Application may be exchanged with the administrators of related programs. By checking the box below, the Applicant consent's to the use of his/her personal information to contact him/her regarding programs and activities of the BCFGAs.
